PROCESS to apply to the Dyslexia Center:

1. Complete application for the Center.
2. Attach a **COPY** of your current (administered within the last three years) psychological evaluation from a licensed professional. The evaluation must include a summary of tests administered to determine a diagnosis, verification of average or above average intellectual abilities, individual achievement test scores, and language scores.

Please do not submit your only copy of your evaluation.

3. Mail application, copy of psychological evaluation, and a check or money order made payable to **Nicholls State University** for a non-refundable \$25.00 application/processing fee to:

IMPORTANT Policies of the Dyslexia Center:

The Dyslexia Center seeks highly motivated students who have been diagnosed as having a learning disability and who have been successfully mainstreamed in college prep courses throughout the four years of high school.

Students must complete all steps in the admission process to both Nicholls State University and the Dyslexia Center before an admission decision to the Dyslexia Center can be made. Students must first be accepted into Nicholls State University before being accepted into the Dyslexia Center.

Applications for Dyslexia Center admission are processed on a rolling basis. However, students should be aware that there are a limited number of openings in the Center and should apply early to assure space availability.

Dyslexia Center Application Deadlines:

Fall – August 1
Spring – December 1
Summer – May 1

Dyslexia Center enrollment decisions are made after careful review of all submitted documentation. Students may be selected for enrollment in the Dyslexia Center or may be placed on a waiting list. The final enrollment decision is based upon selecting the option best suited for the individual student to provide a successful experience at NSU. Students will receive written notification of the committee's decision concerning enrollment in the Center.

The Dyslexia Center charges a semester fee for enrollment in the Center. If a student is accepted into the Dyslexia Center, the Center fee will be added to the student's invoice along with NSU tuition and fees.
