is placed under sanctions (listed below) of the Code of Student Conduct, which are:

- 2.46.3 Disciplinary Probation expiring not before Month, Day and Year and not beyond Month, Day and Year. All terms of probations are listed below.
- 2.46.6 Disciplinary Fine in the amount of \$100.00. If the fine is not paid, it remains on the student’s record as indebtedness to the university which renders the student ineligible to register for subsequent semesters.
- 2.46.8 Suspension of Rights and Privileges. Immediate eviction from the Residence Hall System. Immediate ban from all housing and non academic/classroom buildings.
- 2.46.9 Suspension of eligibility for official athletic and non-athletic extracurricular activities.

In addition to the above sanctions you are required to:

1. Cease and desist from all contact with the victim in this case. Contact shall be defined as, including but not limited to face to face, social networking, all electronic, as well as telecommunication.
2. Seek counseling to address your behavior relative to this incident.

Counseling is not a punishment - it is an opportunity for you to address your issues and change your behavior so that you can lead a healthier academic and personal life. You may select the licensed counselor of your choice. Note that the University does have a Counseling Center in which services to students are free of charge. Any cost for outside services will be paid by you. You agree to: permit the University to provide the counselor access to University records; to permit the University to verify that you are seeking counseling services relative to this matter and to permit University staff to speak to your counselor to determine whether it was a mutual agreement to discontinue counseling or whether you decided to discontinue counseling on your own.

These sanctions are the result of this student's violation of the Code of Student Conduct Sub-Sections

1.6	Physical abuse by striking another student in the eye.
<p>Jarious Capri admitted to striking Capri Jarious in the eye after Jarious went to Capri’s Family Housing Apartment trying to straighten out the matter of the missing Play Station 3. Capri was also criminally charged with Simple Battery. At the time of the incident Jarious denied University Police’s request to seek medical attention. See Police Report #2010-000000 for details of the incident. Unconfirmed medical reports indicate that the victim’s eye is fractured and surgery may be required to insert a plate to prevent eye ball from falling into the nasal cavity.</p>
