#### REASON FOR CHANGE

## Procedure(s):

PROPOSED CHANGE: In order to create a more equitable working environment and to align with best practices of other universities, we would like clear guidelines for teaching loads. For tenure track and tenured professors, a "4-4" (12 credit hours per semester, 24 per year) teaching load will be the maximum allowed. For instructors, it will be a "5-5" (15 credit hours per semester, 30 per year). If a professor or instructor teaches more than their respective limits, they shall be given adjunct or overload pay. Exceptions may apply for independent study courses and internships. Also, the proposal is worded to allow for flexibility within particular semesters (ex. a 4-4 may be a 5-3 if necessary, but the overall academic year hours would not exceed 24).

#### 2.7.3.1 Probationary and Tenure Contract Faculty

The teaching assignment for full-time probationary and full-time tenure contract faculty shall be a minimum of 24 semester credit hours, or its equivalent, of instruction in organized undergraduate classes in an academic year. The assignment of library faculty shall be a minimum of 40 hours per week.

## 2.7.3.2 Term Contract Faculty

The teaching assignment for full-time term contract faculty shall be a minimum of 24 semester credit hours, or its equivalent, of instruction in organized undergraduate classes in an academic year or 12 semester credit hours in a semester. The teaching assignment for part-time term contract faculty shall not exceed 9 semester credit hours in a semester. The assignment of library faculty shall be 40 hours per week.

#### 2.7.3.1 Probationary and Tenure Contract Faculty

The primary teaching assignment for full-time probationary (tenure track) and full-time tenure contract faculty shall be no more than 24 credit hours per academic year or its equivalent. Exceptions may apply for independent study courses and internships. Any additional teaching assignments must be agreed upon by faculty for an overload or adjunct fee. The assignment of library faculty shall be a minimum of 40 hours per week.

#### 2.7.3.2 Term Contract Faculty

The primary teaching assignment for full—time term contract faculty shall be no more than 30 credit hours per academic year or its equivalent. Exceptions may apply for independent study courses and internships. Any additional teaching assignments must be agreed upon by faculty for an overload or adjunct fee. The teaching assignment for part—time term contract faculty shall not exceed 9 semester credit hours in a semester. The assignment of library faculty shall be 40 hours per week.
